## 2024 OPPORTUNITIES FOR EMPLOYEE BURSARY AWARDS

- 1. Applications are invited from permanently employed staff (employed either in terms of the Public Service Act of 1994 or the Employment of Educators Act of 1998) based either in schools, other education department's offices or at head office.
- 2. This bursary opportunity is intended only to those employees who wish to study through UNISA or are already studying at UNISA. The bursary will, however, not settle debt incurred prior to the award and the signing of a bursary contract.
- 3. The qualification applied for or already being registered for must be in line with the job description of the employee.
- 4. The bursary will be awarded for studies commencing in the first semester of the 2024 academic year. It will be the responsibility of an interested employee to apply for admission at UNISA during August and September of 2023. The individual applicants will also be responsible for payment of the application fee.
- 4. As part of the application, applicants must attach recently certified copies of the identity document (card to be copied on both sides), matric certificate, proof that they are already registered and the copy of academic transcript (if already admitted at UNISA) and latest payslip.
- 5. Applicants must clearly indicate the qualification they are requesting funding for using the official qualification title used by UNISA.
- 6. Application forms must be hand delivered to the nearest HRD office either at head office or one of the district offices. The closing date for submission of applications to the offices detailed below
